
But the pandemic wasn't the only defining moment in fiscal year 2020.

In collaboration with the Greater Susquehanna Valley YMCA, we launched our first joint venture with Geisinger at the Miller Center for Recreation and Wellness in Lewisburg. Together, the entities will continue to live out the inspired vision of the Miller family for a healthier community.

The Hospital formed Evangelical Regional Mobile Medical Services (or ERMMS) to support area ambulance companies struggling to recruit new volunteers and ensure quality emergency medical services are available regardless of where you live or when you need them.

We continued to work toward the completion of our most ambitious construction project to date—the 112,000-square-foot Patient Room Improvement, Modernization, and Enhancement project we commonly call PRIME. We look forward to celebrating the opening of this facility with you in fiscal year 2021.

While like most everyone I will remember fiscal year 2020 for the unprecedented challenges of navigating a pandemic, I also will proudly remember that we continued doing what we always do—providing for the health and wellness needs of our community and defining what it means to be the community's Hospital.

Prepared for the Unthinkable

In March 2020, life in the Central Susquehanna Valley changed.

The COVID-19 pandemic, originating in China, arrived in the United States. Cases were first observed on the West Coast but quickly started to show up in metropolitan areas on the East Coast. As cases in New York City and southeastern Pennsylvania mounted, it quickly became apparent that it wasn't a matter of if, but when, the Valley would see its first evidence of COVID-19.

Operational Response

Evangelical Community Hospital's response, in development since December 2019, was carefully measured and highly strategic.

On March 19, 2020, the Hospital enacted its Pandemic Plan in conjunction with orders from Governor Tom Wolf that healthcare organizations in the state immediately suspend

elective procedures. Operating rooms would only be permitted to perform procedures qualifying as emergencies or essential to the immediate health of the patient.

Approximately 250 Evangelical employees identified as not essential to operations were immediately furloughed. The Hospital was the first healthcare entity in the region to send a sizable number of workers home, and the quick action would pay dividends in the long run.

Employees who could complete their essential tasks remotely were ordered to do so. Employees whose job functions required them to be on-site continued to work through the pandemic with appropriate infection control protocols—including the use of personal protective equipment (PPE), daily screening, masks, and physical distancing—as recommended by the Centers for Disease Control and PA Department of Health.


Employee Reflections

Dining Services Associate, Nutritional Services

Dining room service during the pandemic quickly tightened for safety. Open to employees only, menu items changed drastically to pre-packaged items and to limited hot foods. The entire Nutritional Services team adapted quickly and effectively to modified meals, the integration of community-donated food items, and fewer staff to work both the kitchen and serving line.

"As staffing levels changed to accommodate fewer people being served, I just shifted my attention to what needed to be done differently. What was most important was making sure what could be done to feed our employees was done."

With area schools shuttered for the remainder of the school year, the Hospital established childcare for employees working on-site or remotely at the Miller Center for Recreation and Wellness, Lewisburg.

Senior Hospital leadership was split into four groups of four, and an on-call schedule was established to ensure there were always clinical and non-clinical leaders on-site, on-call, and working remotely. The groups were on-site for 12-hour blocks (7:30 am to 7:30 pm) seven days a week. The Hospital's CEO was in the building every third day.

Access to the facility was highly restricted; visitors, vendors, Hospital volunteers, and non-Hospital caregivers were not permitted in the facility through the height of the pandemic. Exceptions were limited to end-of-life situations, births, and patients under the age of 18.

Outpatient services and clinics were consolidated into a central location, and most other locations were closed to patients. Providers from primary and specialty care clinics continued to see patients with acute needs at the Center for Orthopaedics, 210 JPM Road, Lewisburg. The newly renovated facility provided ample space and possessed appropriate areas to screen patients. Patients were also given the option to utilize telemedicine for some appointments.

Lisa Yumen, RN, dressed in full personal protective equipment, triages patients in the garage bay located outside of the Emergency Department. This temporary site was set up to allow a segregated area for pre-treatment and to deliver COVID-19 testing of individuals who felt ill enough to present at the Emergency Department.

A screening station was established at the entrance to the Emergency Department to immediately identify suspected COVID-19 cases and keep them segregated from patients seeking care for other issues. An Alternative Treatment Site was established in a tent behind the Ambulance Bay to accommodate a potential surge in cases arriving at the Emergency Department.

An Alternative Testing Site was set up behind the Plaza 15 Shopping Center with the Mobile Health of Evangelical bus serving as the anchor. The site was designed to reduce the influx of those seeking testing at the Emergency Department. From March through June 30, 2,026 people were tested at the site.

A team consisting of representatives from around the organization met daily to ensure the Hospital's supply of essential materials, including PPE, was sufficient to carry on operations. The group effectively sourced materials from traditional suppliers and non-traditional suppliers, including masks and gowns from members of the area's Plain Community and protective equipment manufactured by professors from nearby Bucknell University. To the group's credit, at no time during the pandemic did a lack of supplies impact patient care.

Getting enough supplies quickly became a challenge as the pandemic became more intense. Cathy Kline, Logistics and Distribution Manager, Supply Chain Services, and her team worked day-in and day-out to stock up on needed items and to pursue new resources to find supplies.



Employee Reflections

Julie Fohringer

Clinical Risk/Quality Specialist—Quality, Patient Safety, and Risk Management

Many Evangelical employees who were accustomed to coming to work daily and performing duties on-site suddenly found themselves working out of home offices. For Julie, who has worked in an office setting closely around coworkers since 1997, the change of location was refreshing.

"The transition to working at home went really well for me. I found I could do my work effectively and that my team and Director were never far away. We could and did regularly communicate by phone, or Skype, or through Microsoft Teams, and I felt very in-tune with what was happening at the Hospital and within my own Department. As far as balance, at the end of the workday I was able to close the door of the office and start the next day brand new."

The Hospital's inpatient care team established a special COVID-19 unit to care for positive or suspected positive patients in a manner that kept them isolated from other patients and limited staff crossover.

A facilities team worked with clinical leaders to increase the Hospital's complement of negative pressure rooms. Negative room pressure is an isolation technique used in hospitals to prevent cross-contamination from room to room. It includes ventilation that generates "negative pressure" to allow air to be drawn into the isolation room from surrounding areas and directly vented to the outside, as air will naturally flow from areas with higher pressure to areas with lower pressure, preventing contaminated air from escaping the room.

Under normal circumstances, only three negative pressure rooms existed on the nursing floors along with one in the

Emergency Department, one in the Post-Anesthesia Care Unit, one in Catheterization Lab's Procedure Care Unit, and one in the Nursery. Six negative pressure rooms were added to the Intensive Care and Step Down units and two rooms were added to the Emergency Department. One room was created in The Family Place, the Hospital's Obstetric Unit.

As restrictions from the state loosened in May and June, Evangelical methodically reopened its operating rooms to elective procedures, reopened outpatient clinics and services, eased visitor restrictions, dismantled the Alternative Treatment Site, and started to recall furloughed employees. Employees were carefully brought back to work at pace with patient volume increases to ensure the organization remained financially stable.

Infection control protocols—including universal screening, masking, and physical distancing—remained in place.

Communications

In order to ensure the Hospital remained connected to its employees, regardless of status, and the community while serving as a source of reliable, factual information, a clear and powerful communication plan was needed.

With three employees of the six-person department furloughed, the three remaining full-time communication team members delivered.

The team's first priority—as it is in all situations—was to ensure the workforce felt informed and Hospital leadership was transparent with what was happening in the organization and the community. From March 15 through May 31, two COVID-19 updates were sent daily to the entire workforce. The first detailed the administrator on call, the emergency response commander for the day, and the infection control officer. The second included operational updates, resources for impacted employees, and any commentary on what was happening outside the walls of the Hospital.



As surgical services slowed down because of the ceasing of elective procedures, John Lewis, RN, Director of Surgical Services, and his team adapted. Many began to fill different, much-needed roles outside of their normal duties. He noted that they missed the camaraderie of being together but worked hard to do the very best for the Hospital.

The daily updates were repeated on the Employee Portal, a page previously established on the external website that allows employees offsite to access important information that previously would have only appeared on the organization's intranet. This allowed remote employees and those furloughed to stay engaged with what was happening at the Hospital. With the help of People and Culture, resources for employees on unemployment claims, benefits, and more were added to the page.

From March 19 to June 30, there were more than 51,900 page views for the Employee Portal.

The COVID-19 pandemic was and is a public health crisis, and people naturally turned to their Hospital for accurate, timely information.


With the majority of the public sequestered in their homes, social media quickly developed into a key channel of communication. Audiences for all of the Hospital's social media platforms grew significantly over the course of the pandemic; Facebook alone jumped 13 percent in three months. The team used infographics created for social media to provide access to resources and educate the public on what they could do to protect themselves and their families. Social reach—defined as the content coming to someone's news feed—totaled more than 20,000, while social engagement—defined as taking some action, liking, or sharing—totaled more than 1,500 for those infographics.

The Hospital also created a coronavirus webpage, accessible from the home page or the direct URL: evanhospital.com/virus. The page included updates on Hospital operations, daily COVID-19 testing statistics, video content, links to sites such as the Centers for Disease Control and PA Department of Health, and other helpful resources.

Year-over-year data show website traffic increased by nearly 47 percent from March 19 to June 30, 2020, as compared to the same period in 2019.

In addition, near daily press inquiries were fielded, several emails were sent to the Hospital's database of more than 30,000 local email addresses, a number of short videos were produced, and a number of media and community conference calls were organized.

Community Support

It's often said that in difficult times, one's true character shows. This is certainly true of the Central Susquehanna Valley!

Evangelical received numerous offers from employees, community members, and businesses to generously donate supplies, food, and services to support the Hospital as it responded to the COVID-19 pandemic. A list of the most needed supplies was maintained on the Hospital website along with directions on how to go about completing a donation. Support was recognized through social media and advertisements in local print media.

Along with supplies and food, the Hospital gratefully accepted financial support from individuals and businesses. Donations to the COVID-19 Emergency Fund helped offset net revenue losses stemming from the suspension of elective procedures as well as the unplanned purchase of important equipment and supplies related to the pandemic response.

Many in the community simply wanted to express their admiration and gratitude for those working to care for their health

and wellness during the pandemic. The communications team created an email address—together@evanhospital.com—to accommodate messages of hope and support. The resulting images, cards, and well-wishes were posted on the Hospital's intranet for employees and shared through social media.

Financial Impact

With prudent management of its expenses as well as the receipt of state and federal grants, Evangelical survived the COVID-19 pandemic's impact on its finances through the close of fiscal year 2020 and turned a hopeful eye to fiscal year 2021.

While the Hospital did not meet budget projections for the fiscal year and lost revenue was significant, its financial performance outpaced that of many healthcare organizations.

When the Hospital instituted pandemic procedures internally, some services began to slow or stop. This impacted staffing, and the difficult decision was made to either reduce hours or temporarily furlough some employees. Tools were put in place for these employees to continue receiving communication so they could stay in touch with what was happening within the organization.

"I wasn't upset by being one of the furloughed employees. I understood why the decision was made. I quickly assessed my financial situation and felt confident that my husband and I could manage. Time is golden, and being off allowed me to stay busy, help my grandson with his fifth-grade studies while his parents worked, and I was able to have the benefit of continued healthcare coverage that I needed for my husband and myself."



U.S. Senator Bob Casey Visits

U.S. Senator Bob Casey visited the area on July 22, 2019, with a stop at Evangelical Community Hospital. The purpose of the visit was to have a roundtable conversation with physicians and patients on pre-existing conditions. The participants shared how these conditions impact the care of the patient with regard to insurance and the Hospital with regard to reimbursement and patients coming to the Hospital later and needing more extensive care.

Moderating the discussion was a representative of the Pennsylvania Health Access Network. Joining from Evangelical were James Stopper, Vice President of Finance and Chief Financial Officer; John F. Devine, DO, FACP, CPE, Vice President of Medical Affairs; John Pfeifer, MD, Interventional Cardiologist with the Heart and Vascular Center; and John Turner, MD, FACS, Medical Director of Cancer Services.



The opportunity to share expertise with governmental leaders allows Hospital administration and medical professionals to talk about the issues that most impact the care of patients.

Joint Venture Impacts Community Wellness

In August 2019, Evangelical Community Hospital, Geisinger, the Miller Center for Recreation and Wellness, and the Greater Susquehanna Valley YMCA came together to make a positive, lasting impact on the health and wellness of the region.

Evangelical and Geisinger formed their first joint venture at the Miller Center. The center was transferred to the joint venture by the Miller family, who generously provided the funds to found the facility. The YMCA was contracted to run the day-to-day

operations. In addition, the joint venture acquired six acres around the facility to expand parking, make room for two new pools—one for competition and one for general aquatics—and create an enhanced full-day childcare center that will include after-school care and more.

The new entity is known as the Lewisburg YMCA at the Miller Center, powered by Evangelical and Geisinger.



By coming together in one facility, the four organizations are able to offer comprehensive and affordable wellness and recreation programs for all generations in the heart of the community.

In October 2019, Ryan McNally was named Director of the venture. McNally has been part of the Evangelical family of employees since May 2016, first serving as a Community Health and Wellness Instructor and Fitness Center Attendant, then advancing

in August 2016 to the role of Community Health and Wellness Educator and Wellness at Work Coordinator. No stranger to the Miller Center, McNally served as a personal trainer starting in 2017.

On December 16, 2019, a ribbon-cutting ceremony was held celebrating the transition of the Miller Center to the joint venture of Evangelical and Geisinger and welcoming the YMCA as the operational partner.

Stepping in to Shore up Emergency Services

In an effort to ensure surrounding communities continue to receive consistent, high-quality emergency medical services, Evangelical Community Hospital announced the formation of Evangelical Regional Mobile Medical Services (ERMMS) in fiscal year 2020.

"The national crisis of staffing ambulances with volunteers has been impacting our region for some time," said Jonathan Bastian, PA-C, Operations Director for ERMMS. "Many services are seeing their core group of volunteers age out of active duty, and fewer new volunteers are stepping in to fill the gaps."

"As a healthcare leader in the region, we understood we needed to find a new approach in order to provide strong, regional emergency services for all people regardless of the time



of day and where someone lives,” said Kendra Aucker, President and CEO, Evangelical Community Hospital. “ERMMS is that new approach.”

The Hospital, through its former Pre-Hospital Services department, had been supplying staffing support to various ambulance companies from Middleburg to Watsontown with Emergency Medical Technicians (EMTs) and Paramedics. This had been effective in meeting short-term needs, but this more centralized effort is now addressing the community’s long-term emergency medical response needs.

Mifflinburg Ambulance Company became the first strategic partner in October 2019 as the Hospital subsidiary officially launched. Shortly after the launch, an ambulance was added

to the Hummels Wharf Fire Company to support emergency responses to the village of Hummels Wharf, Monroe Township, and surrounding communities.

While conversations continue with other ambulance companies in the Central Susquehanna Valley, the Hospital remains committed to working cooperatively with all emergency response services.

“Other entities have expressed interest in joining, and we are actively exploring those opportunities,” said Aucker. “But it’s important for everyone to understand we will continue to work with all of the area’s EMS organizations in the same manner we always have—whether they are part of ERMMS or not.”

“A Lifelong Connection to Evangelical”


Susan Evans holds the Lewisburg area and Evangelical Community Hospital near and dear to her heart. It's those strong ties that led her to take part in the Enhancing the Evangelical Experience Campaign and to ultimately be part of the future of healthcare for the Lewisburg community through the Patient Room Improvement, Modernization, and Enhancement (PRIME) project.

Susan's late parents are former Bucknell Golf Pro and Hall-of-Famer Harold L. Evans and Mary Louise Evans. As a child, she lived on the second floor of the clubhouse at Bucknell Golf Club, where errant shots would sometimes find their way into her bedroom through an open window. “It was a wonderful place to grow up. I would look out my window and see so much green. I didn't know that people lived any other way.”

Susan began her life at Evangelical Community Hospital when it was still located across the street from the current site at Evangelical Home. She was delivered by one of the Hospital's founding physicians, Dr. John Arbogast Sr. Susan can recount vividly many experiences at Evangelical. “Over the years, my parents and I have had extended stays at Evangelical, and we have always been so impressed with the care. It's so personal.”

Susan recalled a stay at Evangelical shortly after college. “I had just had surgery and was in my hospital room, which was next door to one of my friends. We were both supposed to be on bed rest, but we would talk back and forth with one another and just laugh and laugh. At one point, our doctor heard us and came into our rooms and told us jokes, which made us laugh even harder.”

Susan recounts the compassionate care her parents received during stays at Evangelical, including a time when a Hospital employee volunteered to stay the night with her father so he wouldn't have to be alone. “He was so kind, and him staying with my dad overnight made us feel so much better. He did so much more than his job, and those are the kinds of things I think of when I think of Evangelical—the personal touches.”

Robert Rice, CPA, Susan's longtime advisor, was instrumental in helping Susan design her gift. "Susan has always had Evangelical in her heart. When she heard about the PRIME project from Dr. (Gale) Reish, she knew this was something she wanted to be a part of and use as a means of honoring her parents and dear friends."

Susan and Robert recognized immediately that this project was a good fit for Susan and her interests in supporting her hometown community. Susan stresses that at Evangelical, it's the people who

really make the difference. "Everywhere you go, you feel a sense of kindness and a warm reception from a staff that is there to welcome you, take care of you, and comfort you."




In total, the event raised more than \$51,000, the highest since the event began nine years ago. The proceeds provide funds



Financial Report

Fiscal Year 2020

The global COVID-19 pandemic cast a wide shadow over Evangelical Community Hospital's operations and finances throughout the last half of fiscal year 2020.

Loss of surgical volumes from a state-mandated suspension of elective procedures and the temporary closure of most employed physician practices contributed to an overall net patient revenue loss of \$22.8 million.

However, with prudent management of expenses and state and federal grant funding, Evangelical finished the fiscal year on solid financial footing.

The Hospital reduced expenses by about \$12 million, including salaries and wages for employees furloughed or with reduced work hours during the temporary closure of some services and additional expenses incurred due to COVID-19. Evangelical was one of the first employers in the region to address workforce expenses, and the Hospital's measured return to services—matching employee recalls with patient volumes—was key to its financial survival.

The Hospital received \$13.8 million in grants and payroll tax credits as well as \$17.6 million in advance Medicare payments. The advance Medicare payments will need to be repaid unless something changes at the federal level.

All told, Evangelical finished fiscal year 2020 with a net operating margin of 2.51 percent.

"We finished the year in a better position than we expected, and we're cautiously optimistic as we move into fiscal year 2021," said James Stopper, Vice President of Finance and Chief Financial Officer. "There's still work to be done. We need to continue managing our expenses in pace with slowly improving patient volumes and simultaneously remain ready for a spike in COVID-19 cases."


"That said, I'm extremely proud of how we as an organization have managed the COVID-19 pandemic so far," he added.

Evangelical now turns to the new fiscal year with a fiscal goal of maintaining its A- Standard & Poor's rating while completing and operationalizing its most ambitious construction project to date—the Patient Room Improvement, Modernization, Enhancement (or PRIME) project. 
Net Patient Revenue Comparison

Community Benefit Report

A large part of being a community hospital is caring for others beyond the Hospital's walls. The first three quarters of the fiscal year, Evangelical's Community Health and Wellness team was busy at work, going into the community providing free or low-cost screens, offering work wellness programs, delivering school-age education programs, and more. The final quarter saw a stall in outreach to the community as events had to be cancelled as the COVID-19 pandemic became more pronounced.


One opportunity that presented itself in 2020 was the ability to fit some Lewisburg Area School District students with new bike helmets through a grant to help students be safer during the summer months.

The Lindig Lewisburg Foundation Fund at the First Community Foundation Partnership of Pennsylvania provided the grant of \$750 to Evangelical Community Hospital in January 2020. The funds were used to purchase 125 helmets for students in need at Kelly Elementary. Evangelical's Community Health and Wellness educators worked with the school to properly fit each recipient with the appropriately sized helmet.

"It's important for us to emphasize safety and prevention in the neighborhoods we serve," said Sheila Packer, Manager, Community Health and Wellness. "These grant funds make it possible for us to extend our outreach to those children who may not otherwise have access to a helmet and to speak with them one-on-one about bicycle safety."
