


And we remain prepared to pivot and provide safe, effective care should COVID-19 once again ravage our community.

# Always an Eye to Tomorrow

Over the last two years, the leadership of Evangelical Community Hospital has remained focused on positioning the organization to continue caring for the community well into the future even through the challenges of a global pandemic.

In fiscal year 2022, Evangelical continued its march to an integrated electronic health record, set the foundation for expanded services in an important market, secured valuable real estate contiguous with other owned property, and kicked off the expansion of one of its key service lines.

## An Epic Transition

The Hospital began its transition to Epic, an integrated electronic health record (EHR) platform, prior to the onset of the pandemic and resumed the effort in fiscal year 2022.

The transition is one of the cornerstones in Evangelical's long-term strategy to remain an independent, community hospital. Moving to a fully integrated EHR will improve staff and provider efficiency across the organization—from clinical interactions to processing laboratory testing results, billing, and everything in between.

"This project truly impacts every corner of this organization," said Dale Moyer, Vice President of Information Systems and

Chief Information Officer. "It's going to be a huge lift for our employees and providers, but the end result will be a system that works for all stakeholders—clinical staff, support staff, and most importantly our patients."

In addition to the integration of internal systems, the project includes a transition to a more intuitive and user-friendly patient portal known as MyChart. Patients will be able to request prescription renewals, view test results, send messages to providers, and eventually request appointments online.

Over the last several years, the Hospital has paused its IT investments as senior leadership and the Board of Directors mapped out the organization's strategic direction. In fiscal year





2023, Evangelical will go live with Epic, an effort that will bring the organization's IT systems and hardware up-to-speed with the level of care its employees and providers are delivering to patients and the spaces in which that care is being provided.

### Expanding in Selinsgrove

As part of its continuing efforts to ensure the communities it serves have convenient access to a variety of important healthcare services, Evangelical launched two facility-related efforts in fiscal year 2022.

First, the Hospital successfully leased space in the former Sears store at the Susquehanna Valley Mall adjacent to other healthcare providers already established in the mall. In addition, Evangelical purchased the building at 21 Susquehanna Valley Mall Drive.

The Hospital plans to renovate the space and move SUN Orthopaedics of Evangelical's Selinsgrove location and the Selinsgrove Imaging Center from the facility at 21 Susquehanna Valley Mall Drive to the mall.

"We are excited about the opportunities these projects present for our patients in the Selinsgrove area," said Kendra Aucker, President and CEO, Evangelical Community Hospital.

"The leased space in the mall provides convenient access for patients needing orthopaedic care or imaging services, particularly those already seeking healthcare services from other providers at that location. And the location along Susquehanna


Valley Mall Drive affords us a fantastic opportunity to provide expanded access to a variety of specialty practices and services in the Snyder County region."

### At the Heart of it

Evangelical enjoys a well-earned reputation for placing its patients at the center of everything it does.

Recognizing the growing need for Cardiovascular Services, the Hospital is expanding its Heart and Vascular Center in Lewisburg. The project includes shifting the central corridor in the Professional Office Building to the north side of the building and expanding the Center to accommodate more patients and more providers.

"Heart and Vascular was the only service line in fiscal year 2022 to exceed pre-pandemic volumes," said Aucker. "Clearly, people in the community need high-quality cardiovascular care, and we're committed to improving their access to this life-changing and life-saving care."



### A World of Possibilities

When the Baylor-Hamm Companies announced they were closing the iconic Country Cupboard Restaurant and Gift Shops along Route 15, Evangelical leaders immediately recognized the strategic opportunities associated with real estate along the busy highway and contiguous with other tracts of Hospital-owned property.

"We don't have any immediate plans for the former restaurant and gift shops," said Aucker. "What we do know is having this property and first right of refusal on surrounding businesses gives us a level of flexibility we would not have without it."

# New Certification Takes Hip and Knee Care to the Next Level

In early 2022, Evangelical was recognized as a DNV certified Hip and Knee Replacement Center. The Hospital's hip and knee replacement program is made possible through the collaborative efforts of SUN Orthopaedics of Evangelical, Surgical Services, the inpatient Center for Orthopaedics team, and Rehabilitation Services of Evangelical.

"This certification is a huge accomplishment and speaks to the quality of care that we provide our patients," said Kendra Aucker, President and CEO of Evangelical. "Not only does it represent excellent patient outcomes and low complication rates, but it also signifies the exceptional level of care our Hospital provides for those undergoing hip and knee joint replacement."

The DNV Hip and Knee Replacement Program Certification, based on standards set forth by and considering the guidelines of the American Academy of Orthopedic Surgeons, recognizes program excellence in patient care and outcomes.

DNV certification as a Hip and Knee Replacement Center validates the Hospital's excellence across the spectrum of hip and knee replacement care, from diagnosis to treatment, rehabilitation, education, and outcomes.

"The certification validates that Evangelical has the resources and commitment to provide the best possible care for hip and knee replacement—not only while under direct care but also through needed support and education so patients can recover at home safely for the greatest success," said Charles Cole, MD, Surgeon, SUN Orthopaedics of Evangelical.

# Purposeful Conversations Drive Evangelical's Family Feel for Employees and Patients



Vital to a successful workforce is understanding employee needs in balancing work and home. Creating a workplace atmosphere that values employee needs and offers them support is just as valuable as pay and benefits.

"With employees spending the majority of their waking hours in the work environment, it is essential for the Hospital to be a welcoming place where their ideas and efforts are valued and openly appreciated," said Rachel Smith, MPA, SHRM-SCP, Vice President of People and Culture.

The global pandemic stretched everyone to their limits mentally, emotionally, and physically while caring for the community. For Smith, the People and Culture team, and Hospital leadership, it was time to reacquaint themselves with a workforce that has a new perspective on what they want out of their work and their workplace.

## Getting Back in Touch with the Workforce

In May 2022, an employee/provider engagement survey was introduced through Press Ganey, where all providers and employees were invited to share their feedback on key areas within the work setting. Engagement is measured by a combination of loyalty, pride, and willingness to recommend the Hospital as a good place to receive care and work.

Of those who took the survey, 77% of employees and 88% of providers feel engaged, placing Evangelical in the 52nd and 70th percentile, respectively, in the Press Ganey database.

These numbers will be used as a baseline for future surveys to see if the needle on engagement moves in the coming years.

Employees indicated they strongly feel that the organization cares about its clients/patients and contributes to the community.

100% of providers feel their clinic/group provides high-quality care and service.

93% of providers feel their work is meaningful and makes a real difference.

70% of employees feel they are able to disconnect from work communications and that the organization is providing mental and emotional health resources to employees.

## Survey Focus Areas



Using the survey results, leadership plans to take a deep dive into the data at the organizational and departmental levels, creating action plans to take advantage of the organization's greatest opportunities.

What is clear from the 2022 survey is that the entire workforce feels patients are well cared for at Evangelical Community Hospital.

### Recruitment and Retention Becomes a Primary Focus

Prior to the pandemic, the Hospital was beginning to see a shift in recruitment of staff. Key healthcare professions, including nursing, medical lab scientists, respiratory therapists, EMTs, and paramedics, were on the decline based on the number of students entering those specialties, while the need to fill open positions was growing.

The pandemic exacerbated the problem when long-term employees in health professions began to exit the field—from burnout, early retirement, and desire for a career change—leaving even more open holes in plans for full coverage. Evangelical and other healthcare organizations across the nation found themselves in the position of seeking to fill open job opportunities with an even more limited resource pool of new graduates and active, experienced job seekers.

To expand the Hospital's recruitment approach, a partnership was formed with Hueman—a recruitment outsourcing group—whose main mission is to connect the right people with the right job at the right time. The collaboration with Hueman focuses on developing relationships with passive candidates who may not know about healthcare-related positions or Evangelical as an employer.

As fiscal year 2022 came to an end, an innovative vision was being realized. After nine months of preliminary work, the Hospital solidified a partnership with PassportUSA, an international talent group that works to fill career opportunities in the United States with internationally trained healthcare professionals.

In the United States, opportunities are vast while the talent pool is declining. In the Philippines, it is the exact opposite. Exceptionally qualified healthcare workers are too numerous for the number of positions available.

By working with PassportUSA, the Hospital will be able to bring equally qualified nurses and medical lab scientists to the United States for a three-year work commitment with the opportunity to join the Evangelical family of employees permanently at the end of their contract. The first anticipated nurse from this program was set to arrive at the beginning of fiscal year 2023.

## Newly Introduced Programs in Fiscal Year 2022

### EMT Trainee Program

This four-month, fully funded EMT training program allows participants with a high school diploma, GED, or an approved secondary school co-op program to earn a paycheck while preparing for a new career. A bonus is guaranteed employment upon successful completion of training and EMT certification.



The first round was funded through the PAsmart grant, an offering of the Pennsylvania Department of Education. Moving forward, the existing program will expand from Penn College to also include Harrisburg Area Community College.

### Nurse Emeritus

The Hospital created the Nurse Emeritus role to lead newly graduated RNs through a relationship-based, educational program that guides new nurses as they encounter real-life clinical situations. The first two Emeritus RNs were hired and began mentoring Evangelical's newest nurses in 2022. Emeritus Nurses will be part of the existing Nurse Residency program, which is designed to support the development of technical skill, insight, and confidence of novice nurses through mentorship, with a goal of developing intuitive problem-solving skills.



### Nursing Assistant Training Program

This two-week training program is designed for individuals with limited to no prior experience but who have a strong desire to work as part of Evangelical's healthcare team. The course offers intense, short-term classroom training, and those who successfully complete the program are given priority for hire across all shifts, units, and status (full-time, part-time, or per diem).



## Diversity, Equality, and Inclusion Explored

In September 2021, the Hospital was awarded a grant from the Southern Tier Community Fund at the First Community Foundation Partnership of Pennsylvania to support its commitment to diversity, equity, and inclusivity (DEI) training.

"These grant dollars will enable us to continue educating our workforce on important topics impacting our ability to compassionately care for people from diverse backgrounds and experiences," said Kendra Aucker, President and CEO of Evangelical Community Hospital.

The funds support Evangelical's commitment to creating safe spaces where employees, volunteers, patients, and community partners can present all dimensions of themselves.



The funds also further extended learning for management staff, Board members, and physician leaders to support the organization's commitment to diversity, inclusion, and equity.

In March 2022, management staff were led through a special session of open-minded, DEI-focused conversations by Amita Mehta, Business Strategist. Through the sharing of Mehta's personal experiences of being a woman, a refugee, and a member of the LGBTQ community while carving out a career as a high-level executive, she was able to relay the struggles that can be felt when trying to balance work while remaining true and authentic as an individual.

To bring a more at-home perspective, Board member Susan Fetterman, and Malcolm MarFan, MD, Hospitalist, took part in a town hall discussion led by Mehta about their personal experiences of career, inclusivity, and the challenges they faced along the way.

With the air clear to share in a safe zone, staff broke out in small groups, which generated good conversation around the ideas of DEI.


In the report out after the group discussions, the room heard ideas and thoughts that will define not only leadership perspectives but also where the organization needs to go to be more diverse, equitable, and inclusive.



## Adaptability and Desire to Learn Set the Stage

Being open to new ideas sets the stage for the success of Evangelical in the future. Over the past two years, the workforce has shown the flexibility and adaptability they are capable of in some of the most challenging and ever-changing situations.

With the patient constantly at center, staff, providers, and leadership continue to demonstrate the resiliency of Evangelical as an independent Hospital and the desire to be a welcoming and safe place for all who walk through its doors.



## Next Steps Toward a DEI Culture

- Formally establish an internal diversity, equity, and inclusion council that will establish metrics to measure success.
- Create new learning opportunities for enhancing cultural competency throughout and at all levels of the organization.
- Identify opportunities to improve diversity in Board and leadership positions.
- Enhance recruiting, hiring, and development opportunities with a focus on diversity.
- Use feedback from the Patient/Family Advisory Council, employee/provider engagement surveys, and other data sources to inform strategies for the Hospital moving forward.

# COVID-19—Another Year of Response and Learning



With the global pandemic extending into another year, the Hospital continued to respond in fiscal year 2022. Highs and lows continued in that response as teams pulled together during patient surges. As a community hospital, Evangelical excelled in its efforts to care for patients, to find innovative solutions for challenges, to work with employees on mandates, and to be a voice for hospitals with area and state leaders.

## Innovation at its Best

The Hospital led one of the 10 highest-scoring projects in a statewide awards program spotlighting how Pennsylvania hospitals served their communities during the COVID-19 pandemic.

The Hospital and Healthsystem Association of Pennsylvania's (HAP) COVID-19 Response Innovation Awards showcase the innovative teams, solutions, and projects that have helped shape the healthcare community's response to, understanding of, and resilience to the pandemic.

Evangelical was recognized for its early institution of COVID-19 testing for the community through an alternative testing site. The quick establishment of the site answered the testing needs of the community, with a convenient and safe drive-through method, while making it possible to separate those needing testing from those seeking treatment for COVID-19 and other illnesses in the Emergency Department.

The COVID-19 testing site at Evangelical, which began behind Plaza 15 in the early days of the pandemic response and later moved to a dedicated site at St. Mary Street in Lewisburg, was the longest-running public testing site in the region. It afforded individuals a convenient drive-through option, safe from the elements, in a no-appointment-needed environment. From inception on March 19, 2020, until closing on February 19, 2022, due to lower volumes and greater availability of home testing kits, Evangelical's COVID-19 testing site collected 25,614 samples.

HAP received nearly 80 entries for the award. The blinded applications were evaluated by a group of independent judges from Pennsylvania and across the nation.

### Rural Health Leadership

Kendra Aucker, President and CEO, was presented the Rural Health Leader of the Year award from the Pennsylvania Office of Rural Health (PORH) during fiscal year 2022. The award recognizes an exemplary health program that addresses an identified need in a rural community utilizing unique, creative, and innovative approaches.

In this case, the area lauded was Aucker's commitment and dedication to leading COVID-19 testing in the community and for her support of staff at the Hospital in one of the most challenging times in recent healthcare history.

The nomination noted, "When vaccines became available, the Hospital was scheduling appointments for frontline workers and moved to offering vaccines to the public as quickly as possible through weekly clinics. Kendra Aucker was a vocal proponent for infection prevention efforts, including masking, social distancing, and staying home when sick. She also served as an advocate for local politicians and policy leaders, media sources, and more on the status of healthcare during the pandemic and the need for strong support of efforts to stop the spread of COVID-19."

Aucker was presented the award at the Hospital on November 4, 2021, by Lisa Davis, Director of PORH and outreach associate professor of health policy and administration at Penn State. Aucker noted during her acceptance of the award that while she may be the individual being recognized, the staff and providers of the Hospital as a whole resulted in the successful approach to the pandemic. "I'm standing here because when the obstacles felt insurmountable, everyone on every level at the Hospital rose to the challenge and found solutions."

### Mandates Impact Employee Choice

As COVID-19 vaccinations became more readily available to healthcare workers and the community-at-large, the Hospital stood firm in its recommendation that those who were eligible should receive the vaccine. Though strongly recommended, the Hospital also realized the importance of choice in the matter and gave employees the option of choosing vaccination or being tested regularly before reporting for work if they were not vaccinated.

In the fall of 2021, that choice was compromised when the Centers for Medicare and Medicaid (CMS) delivered a vaccine mandate for healthcare workers that was to go into effect by January 4, 2022. Hospitals not in compliance could lose essential CMS funding. With the Hospital relying on CMS for approximately 60% of its gross revenue, a crossroads had been reached.

As a response, Hospital leadership continued to encourage all employees to be vaccinated and set up additional vaccination clinics to make receiving the vaccine more convenient and accessible. An enrollment period was provided for employees who wished to remain unvaccinated to submit a request for exemption from vaccination based on disability, medical conditions, or sincerely held religious beliefs. Each request was reviewed on a case-by-case basis and exemptions were provided when necessary.

After several delays due to appeals of vaccine mandates on every level, the Hospital pressed forward with its plan of vaccination or exemption with regular testing. By implementation date, 13.5% of the workforce had successfully applied for a religious or medical exemption or were exempt due to a 100% remote work assignment and 86.5% of employees had been vaccinated.

As of March 2022, all new hires must have completed the initial COVID vaccine series or have an approved exemption before their first day of employment.

### **Sharing Feedback with State Health Leaders**

In April 2022, then-Acting Secretary of Health with the Pennsylvania Department of Health, Keara Klinepeter, spent a morning in private meetings with Hospital staff to discuss rural healthcare challenges as well as the COVID-19 pandemic response, as it related to state and hospital interaction.

The discussions were a prime opportunity to give a very real view of the impact the pandemic had on the ability to provide care from the Evangelical perspective to state leaders in the position to affect change.

In attendance that day, in addition to Evangelical leadership, were State Representative Lynda Schlegel Culver, State Representative Jeff Wheeland, and Ann Kaufman, District Director representing Congressman Fred Keller's office.

The frank conversations allowed Klinepeter to gather information that the Department of Health may not have thought of in their planning or implementation of the COVID-19 response.

### **Looking to the Future**

As the fiscal year ended, Hospital staff were able to feel relief from patient surges, begin to take much needed time off, and resume to a more normal pace of healthcare. What did remain in place was the requirement to mask when inside any healthcare facility as imposed by the Pennsylvania Department of Health.

# Financial Report

Evangelical Community Hospital continued to focus on positioning itself for the future in fiscal year 2022, despite a challenging economic landscape.

Rising labor costs, a slower than anticipated return of patient volumes, and record inflation worked to challenge Evangelical's net operating margin while repayment of COVID-19 advanced payments from the Centers for Medicare and Medicaid (CMS) and a weak investment market decreased cash on hand.

Of these challenges, rising labor costs—including significant increases in the utilization of contract labor, recruitment and retention incentives, and rising salaries—represent the highest hurdle facing the Hospital in its march back to a more normalized net operating margin.

It's a fiscal scenario being reported by hospitals and health systems across the state and nation.

In the face of these challenges, Evangelical doubled down on its long-term commitment to the health and wellness of the community—re-launching its transition to an integrated electronic health record (EHR), expanding its Heart and Vascular Center, and improving access to its services in the Selinsgrove area.

"It was a difficult year for us financially," said James Stopper, CPA, Vice President of Finance and Chief Financial Officer. "We continue to work to recover from the pandemic, and we're now doing so with the added financial pressure of rising labor costs. Yet, as an organization, we continue to move forward with key projects that will enhance our ability to care for the community."

The Hospital's transition to Epic, an integrated EHR platform, is the single largest Information Technology project in the history of Evangelical. The move, to be completed in fiscal year 2023, will improve staff and provider efficiency across the organization while providing a more seamless experience for patients as they navigate between healthcare providers in the region.

The Hospital also started several facility-related projects in fiscal year 2022 with the goal of creating new opportunities to drive patient volumes back to pre-pandemic levels. The projects are expected to be completed in fiscal year 2023.

The Heart and Vascular Center will be expanded to accommodate more patients and more providers. Heart and Vascular exceeded fiscal year 2019 volumes in fiscal year 2022, proving it's an area of growth and one of the Hospital's keys to regaining financial stability.

Evangelical is leasing space in the former Sears store at the Susquehanna Valley Mall and finalized the purchase of the building at 21 Susquehanna Valley Mall Drive.

SUN Orthopaedics of Evangelical's Selinsgrove practice and the Selinsgrove Imaging Center will be moved from the facility at 21 Susquehanna Valley Mall Drive to the leased space adjacent to other healthcare providers in 2023.


After the move, Evangelical will explore expanding access to a variety of specialty practices and services at the 21 Susquehanna Valley Mall Drive location, strengthening care options for those in the Selinsgrove area.





As a member of Wellness 360, participants have first access to screenings that are held at different


times throughout the year. Each screening gives individuals the power to make decisions about their health before conditions become harder to manage.
